ORDER

WHEREAS, **Sanskriti Ayurvedic Medical College & Hospital, at 28 KM. Stone, Chhatam Mathura-281401, Uttar Pradesh** was denied permission for the academic session 2019-20 for conducting **100 seats in UG (BAMS) course**, under section 13C/13A of the IMCC Act, 1970 vide Ministry's letter no. L.14014/149/2019-EP dated **19.09.2019**.

2. WHEREAS, a copy of the above mentioned order dated 19.09.2019 was also sent to the Secretary, Central Council of Indian Medicine (CCIM), New Delhi for information and necessary action with the remarks that the resumption of admissions for the academic year 2020-21 may be considered by the Central Government on the basis of a recommendations of the CCIM based on an inspection to verify the Compliance submitted by the College in terms of the provisions under the IMCC Act and the relevant regulations;

3. WHEREAS, the CCIM's letter No.Ref.3-4/2020-Ay (82) dated 25.11.2020 forwarding therewith recommendation of the college to the Central Government based on thorough examination of the visitation report Part-I, indemnity bond, affidavit & latest details of teaching, non-teaching and hospital staff submitted by the college along with the assessment report, as the physical verification by conduction of inspection could not be carried out in view of present COVID-19 pandemic situation for the A.Y. 2020-21. The CCIM had recommended to Government of India for not granting permission for UG (BAMS) course for the academic session 2020-21;

4. WHEREAS, the recommendations and assessment report of the CCIM dated 25.11.2020 and revised teachers status in respect of withdrawal of teacher's code dated 04.01.2021 have been carefully examined in terms of the “Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016, provisions under the IMCC Act, 1970, relevant regulations made thereunder and as per approved Standard Operative Procedures (SOPs) and policies issued from time to time for issuing Permission for this purpose;

5. WHEREAS, on examining the case in light of above notified & approved criteria and on perusal of visitation report, it was observed that the college was not fulfilling the basic eligibility condition and the following deficiencies were found:

- I. There is no Higher faculty (1P+1R) in the 11 departments i.e. Ayurved Samhita & Siddhant, Dravyaguna, Rasa Shastra & BK, Rog-Nidan, Swasthvritta & Yoga, Prasuti & Stri-Roga, Kaumarbhritya, Kayachikitsha, Panchkarma, Shalyatantra, and Shalakyia Tantra against the requirement of 02 (1P+1R) in each as per RMS, 2016 (UG regulation).
- II. Shortage of 01 Lower Faculty in the 04 department i.e. Rachana Sharir, Kriya Sharir, Kaumarbhritya and Shalakyia Tantra against the requirement of 01 in each as per RMS, 2016 (UG regulation).
- III. College website is not updated as specified in sub-regulation (2) of regulation 9 of RMS.
- IV. Total 22 eligible teachers are available against the requirement of 45 as per RMS, 2016 (UG regulation).
- V. 01 Yoga teacher or expert and 02 workers in Teaching pharmacy and Quality testing lab is not available as per RMS, 2016 (UG regulation).
- VI. At least one specialist doctor or one clinical teacher in Shalakyia Tantra, and Kaumarbhritya is not available, as per RMS, 2016 (UG regulation).

6. WHEREAS, considering the deficiencies observed therein as mentioned in para 5 above, the college was given an opportunity of hearing vide Hearing Notice No.L.14014/308/2020-EP-1 dated 14.01.2021 in terms of the first proviso to sub-section (5) of Section 13A of the IMCC Act, 1970 to appear on 18.01.2021 at 9.30 AM before the designated Hearing Committee in the Ministry of AYUSH to present their case and to show cause as to why the permission to take admissions to UG (BAMS) course under section 13C/13A of the IMCC Act for the year 2020-21 should not be denied to the college. The college was instructed to make oral as well as written submissions in respect of the case. In view of COVID-19 situation, Hearing was done virtually i.e., through video conferencing.

7. WHEREAS, the college was represented by Sh. Puran Singh, Registrar and Ms. Meenakshi Sharma, OSD to Chancellor, **Sanskriti Ayurvedic Medical College & Hospital, at 28 KM. Stone, Chhatam Mathura-281401, Uttar Pradesh.** The representatives of the college submitted oral as well as written submissions against the deficiencies conveyed to them vide the Ministry's letter dated 18.01.2021. The shortcomings communicated to the applicant society, submission made by the representatives of the society and observations made by the hearing Committee are as under:

Observation by the Hearing Committee

Since CCIM has not considered higher faculties in Ayurved Samhita & Siddhant, Dravyaguna, Rasa Shastra & BK, Rog-Nidan, Swasthvritta & Yoga, Prasuti & Stri-Roga, Kaumarbhritya, Kayachikitsa, Panchkarma, Shalyatantra, and Shalaky Tantra (names as mentioned second column) and hence, Hearing committee agrees with the CCIM decision. **There are no higher faculties in the said 11 departments.**

Hence eligibility and availability of the said teachers may not be considered further the decision of CCIM on eligibility of the teacher may be taken in account.

Remark

As per hearing committee report **There are no higher faculties in the said 11 departments.** 19 HF in 14 departments for 100 UG seats are required for grant of conditional permission, whereas **06 HF in 03 departments are available. Thus does not fulfil this criterion**

Shortcomings conveyed

2. Shortage of 01 Lower Faculty in the 04 department i.e. Rachana Sharir, Kriya Sharir, Kaumarbhritya and Shalaky Tantra against the requirement of 01 in each as per RMS, 2016 (UG regulation).

Submission of the representatives

College has submitted that they have following lower faculty in the said departments:
Rachna Sharir: Dr. Tanvi Jaywant Kakade, Lecturer from 28.01.2019. **The college has also informed that Dr. Tanvi jaywant Kakade is certified as a Regular teacher under regulation 3(1)(f) of RMS, 2016 by CCIM.**

Kriya Sharir: Dr Nidhi Garg Lecturer from 01.12.2018

Observation by the Hearing Committee

Dr Tanvi, Lecturer, Rachna Sharir has been considered as regular faculty by the CCIM.

However, Dr. Nidhi, Lecturer, Kriya; Dr. Nitin, Lecturer in Shalaky and Dr. Ekta, Dr Praveen have not been considered as Lecturer (regular faculty) by the CCIM.

Dr. Manisha Agrawal has resigned from the college so the hearing committee can not considered her. **The Hearing committee has agreed with the CCIM decision.**

Remark

40 teachers for 100 UG seats are required for grant of conditional permission, whereas **22 eligible teachers are available Thus, does not fulfil this criterion.**

Shortcomings conveyed

3. College website is not updated as specified in sub-regulation (2) of regulation 9 of RMS.

Submission of the representatives

It has been submitted that the college website (www.sanskriti.edu.in/ayurveda) is updated as specified in sub-regulation (2) of regulation 9 of RMS.

Observation by the Hearing Committee
The Hearing Committee has visited & browsed the website and found the following facts: Wrt to list of student admitted, there is only a list uploaded without merit wise, year etc. Wrt to CME & other program etc., there is only photographs are available, details not mentioned. Wrt to clinical material, relevant details not available. Recognition, only letters uploaded. OPD, IPD details and results not available. In view of the above, it is observed that the website is <u>not updated as specified in sub-regulation (2) of regulation 9 of RMS.</u>
Remark
As per hearing committee report Website is not updated as specified in sub-regulation (2) of regulation 9 of RMS. Thus, does not fulfil this criterion

Shortcomings conveyed
4. Total 22 eligible teachers are available against the requirement of 45 as per RMS, 2016 (UG regulation).
Submission of the representatives
It has been submitted that the College have 58 eligible teachers and the same details are also filled on Part-1 Visitation Proforma against the requirement of 45 as per RMS 2016 (UG regulation)
Observation by the Hearing Committee
In view of the facts as indicated at 1,2 and 6, the hearing committee observed that <u>required eligible teachers are not available in the college.</u>
Remark
40 teachers for 100 UG seats are required for grant of conditional permission, whereas 22 eligible teachers are available. 02 department are vacant Thus, does not fulfil this criterion

Shortcomings conveyed
5. 01 Yoga teacher or expert and 02 workers in Teaching pharmacy and Quality testing lab is not available as per RMS, 2016 (UG regulation).
Submission of the representatives
It has been submitted that college has in total 02 Yogateacher, 01 yoga teacher name Ms. Parul Baghel in teaching department and 01 Yoga Teacher or expert (From Swasthavritta & Yoga Department) 02, name Dr. Harsh Dhingra in hospital staff and We also have 02 workers 01, name Mr. Sagar and 02, name Mr. Gyasi in teaching pharmacy and Quality testing lab available as per RMS 2016(UG Regulation) the same details are also filled on Part-1 Visitation Proforma. Annexure-V
Observation by the Hearing Committee
College has submitted that they have 01 Yoga teacher namely Ms. Parul Baghel apart from teacher of Swasthavritta department and 02 workers namely Mr. Sagar and Mr. Gyasi.
On examination the document (at Annexure-5) of Mr. Gyasi & Mr. Sagar, it is observed that at the appointment letter, attendance, salary register, there is no mention about the department or Teaching Pharmacy & Quality Testing lab, (Only indicated MPW/Hospital staffs). Moreover, as per the appointment letter- at first point, It is indicated that both workers will also work under the direction of Sankriti Homeopathy college. <u>In view of this Hearing committee may not consider both workers in Teaching pharmacy and Quality testing lab.</u> Wrt to Yoga teacher (Ms Parul Baghel), it is observed that as per the appointment, she joined the

institute on the pay scale 15600-39100 + 6600 GP, however, as per salary account statement and Form 16 (as provided by the college), Salary not matched. Hence, the Hearing committee could not be ascertained the availability of 01 Yoga Teacher.

Remark

Hearing committee not agreed with the submission of college. Thus, does not fulfil this criterion

Shortcomings conveyed

6. At least one specialist doctor or one clinical teacher in Shalakyia Tantra, and Kaumarbhritiya is not available, as per RMS, 2016 (UG regulation).

Observation by the Hearing Committee

As per the observations at Point- 1 & 2 above, there is no specialist doctor or one clinical teacher in Shalakyia Tantra and Kaumarbhritiya.

Remark

As per hearing committee report there is no specialist doctor or one clinical teacher in Shalakyia Tantra and Kaumarbhritiya. Thus, does not fulfil this criterion

8. WHEREAS, in view of the observation of the Hearing Committee based on submission made by the college representatives during hearing and the recommendations and assessment report of the CCIM referred in para 3 and para 4 above, it is found that, **Sanskriti Ayurvedic Medical College & Hospital, at 28 KM. Stone, Chhatam Mathura-281401, Uttar Pradesh** is not fulfilling the following basic minimum requirements for grant of permission for the academic session 2020-21:

- I. **Total availability of eligible teaching staff is 22 against the requirement of 45. Total percentage of teaching staffs available is only 48.88% against the minimum essential requirement of 90% for conditional permission with full intake capacity. (Teaching staff is essential for conduction of regular classes for the Students and necessary Patient care through the OPD& IPD services and play cardinal role in the functionality of the college & hospital.)**

- II. **There is no Higher faculty (1P+1R) in the 11 departments** i.e. Ayurved Samhita & Siddhant, Dravyaguna, Rasa Shastra & BK, Rog-Nidan, Swasthvritta & Yoga, Prasuti & Stri-Roga, Kaumarbhritya, Kayachikitsa, Panchkarma, Shalyatantra, and Shalakyia Tantra against the requirement of 02 (1P+1R) in each as per RMS, 2016 (UG regulation). (Teaching staff is essential for conduction of regular classes for the Students and necessary Patient care through the OPD& IPD services and play cardinal role in the functionality of the college & hospital.).
- III. Shortage of 01 Lower Faculty in the 04 department i.e. Rachana Sharir, Kriya Sharir, Kaumarbhritya and Shalakyia Tantra against the requirement of 01 in each as per RMS, 2016 (UG regulation).
- IV. At least one specialist doctor or one clinical teacher is not available in Shalakyia Tantra, and Kaumarbhritya, as per RMS, 2016 (UG regulation).
- V. **In view of point II, III, and IV above, there is a total deficiency of 22 Higher Faculty** i.e., 06 Higher faculty in 03 departments are available against the requirement of 28 Higher faculty in 14 departments (28 Higher faculty in 14 departments for 100 UG seats).
- VI. **No faculty available in 02 departments** i.e. Kaumarbhritya and Shalakyia Tanta.
- VII. **The college website is not updated as per the as specified in sub-regulation (2) of regulation 9 of RMS, 2016**(Updated college website is important for disseminating the overall information regarding the college to the public and to the students. It also reflects the regular functionality of the college and hospital).
- VIII. 01 Yoga teacher or expert and 02 workers in Teaching pharmacy and Quality testing lab is not available as per RMS, 2016 (UG regulation).
- IX. **The Teaching faculty is required to be certified by CCIM as per IMCC, MSR Regulation 2016 clause 3 (1) (f), however, the following teachers are not certified by CCIM as well as not considered eligible by the hearing committee. Thus doesn't fulfill the criteria for Teaching faculty/Higher faculty/Lower faculty:**

9. WHEREAS, in view of the shortcomings and deficiencies mentioned in above paras, it is found that the said college is not fulfilling the requirements as per Regulation 3 of the “Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, provisions under the IMCC Act, 1970, relevant regulations made thereunder and as per approved Standard Operative Procedures (SOPs) and policies, for granting Permission for 100 seats in UG (BAMS) course;

10. Further, the said college has also been examined in terms of approved criteria and policies, exclusively relaxed for academic year 2020-21, for granting Permission for 60 seats as well as for 30 seats in UG (BAMS) course and it is found that the college is **not fulfilling either for 60 UG seats or for 30 UG seats for A.Y. 2020-21.**

11. Furthermore, CCIM, vide its recommendation dated 25.11.2020, and revised teachers status in respect of withdrawal of teacher’s code dated 04.01.2021 has recommended for not granting Permission for 100 UG (BAMS) courses for the academic session 2020-21 for the academic session 2020-21.

12. **NOW, THEREFORE**, in view of the shortcomings and deficiencies mentioned above, the college is not fulfilling the basic minimum requirements as specified in the provisions of the IMCC Act and the relevant regulations and the deficiencies of such a serious and fundamental nature that they adversely affect the ability of the College to provide quality medical education in terms of the provisions of the IMCC Act and the relevant regulations, it has been decided by the Central Government for **denial of permission** to **Sanskriti Ayurvedic Medical College & Hospital, at 28 KM. Stone, Chhatam Mathura-281401, Uttar Pradesh** for taking admission in **UG (BAMS) course with 100 seats** under section 13A/13C of the IMCC Act, 1970 for the academic session 2020-21.

13. Further, as per clause 3(1)(a) of IMCC, MSR Regulations, 2016 the following requirements, which are required to be fulfilled by the college by 31st December, 2020, will be examined by the CCIM for considering the permission for session 2021-22:

 - (ii) All the Requirements of “Indian Medicine Central Council (Requirements of Minimum Standard of Educations in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda college); and
 - (iii) All the requirements under the provisions of the IMCC Act, 1970 and relevant Regulations made there under should be fulfilled *in toto*;


