Scholarship Policy Document

Introduction

This policy and procedure document provides details of the various types of Scholarships Endowments available in the college. It also provides details of the selection and bestowal process for Scholarships, both the Government and the non- Government. This document sets out the Scholarships policy, by outlining relevant procedures. It ensures that the management and award of the Scholarships is in accordance with Govt./ UGC Guidelines and is consistent with the vision, mission and values of the college.

Objective

The primary reason that individuals attend a college or university is to get an education. The objective of the scheme is to be award scholarship to meritorious students belonging to economically weaker section of minority community so as to provide them better opportunities for higher education, increase their rate of attainment in higher education and enhance their employability.

Scope of Scholarships

The scholarship is to be awarded for studies in India in government and private higher college/ university, selected and notified in a transparent manner by the state government/ union territory administration concerned. It will cover technical and professional courses at undergraduates and post graduate level.

Purpose of Scholarships

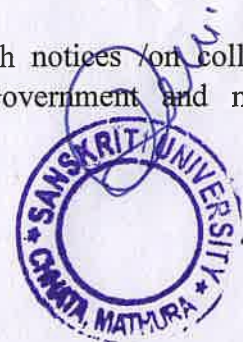
The purpose of the various scholarships available in the college is to harness and nourish the Capabilities of those students who are meritorious and/or experiencing financial barriers to education and skills development.

Scheme Announcement

The scheme will be announced by the concerned state government/union territory administration well in time, through advertisements in the leading language newspaper and local dailies and by using other suitable publicity media.

Procedure

- Students will be notified through College Prospectus through notices /on college website/through media about the different scholarships (Government and non-government) available in the college.

- The scheme is implemented through the state and national scholarship. It is mandatory for all students to apply online on the website.
- Applications along with relevant documents will be invited from eligible students which will be scrutinized by the Scholarship Selection Committee (SSC). The list of short listed candidates will be prepared accordingly.
- Applications with incomplete documents will be rejected. The selected students will be informed by the Committee.
- Application, selection and award processes for Scholarships are coordinated and combined wherever possible in order to: maximize accessibility by students; provide the widest range of possible applicants for individual Scholarships; and optimize both the distribution of Scholarships and efficiency of the process.
- The purpose of the academic merit aspect of the Scholarship is to provide students with a reward for academic excellence. Some scholarships are awarded on need cum merit basis also.
- Only one scholarship is admissible to a student, hence a student who is already availing any scholarship need not apply for another scholarship.
- In accordance with this policy, eligible students for scholarship are selected by the Scholarships Selection Panel/ SS Committee.

Sanskriti University in order to uplift the standard of professional education among young minds and to recognize their hard efforts put to chase their dreams in terms of wonderful career in future, offers scholarship to meritorious students in various courses like B.Tech/B.Com/M. Tech/MBA. On the basis of their marks/grades obtained by them in the qualifying examination.

The meritorious scholarship and the criteria to avail the same in various programmes is mentioned below: -

1. **Bachelor of Technology (B.tech)** : Any candidate who is seeking for admission in B.tech programme offered by the university than he/she is entitled for various scholarship as per his/her 12th score in PCM.
 - a. 90% and above : 90% relaxation in the tuition fee for the 1st year only.
 - b. 85% - 89.9% : 70% relaxation in the tuition fee for the 1st year only.
 - c. 80% - 84.9% : 50% relaxation in the tuition fee for the 1st year only.
 - d. 75% - 79.9% : 35% relaxation in the tuition fee for the 1st year only.
 - e. 70% - 74.9% : 10% relaxation in the tuition fee for the 1st year only.
2. **Master of Technology (M.Tech)** : Any candidate who is seeking for admission in M.Tech programme and has qualified the GATE examination is eligible for 80% scholarship in tuition fee for the 1st year only.
3. **Master of Business Administration (MBA)**: In this category of scholarship any candidate who is seeking admission in MBA and has a valid score in MAT/CAT is eligible for scholarship as per below mentioned criteria:

- a. 99 & above (MAT) or 95% & above (CAT): 95% relaxation in tuition fee for the 1st year only.
- b. 95 – 98.99 (MAT) or 90 – 94.99 (CAT): 90% relaxation in tuition fee for the 1st year only.
- c. 85 – 94.99 (MAT) or 80 – 89.99 (CAT): 50% relaxation in tuition fee for the 1st year only.
- d. 70 – 84.99 (MAT) or 55 – 79.99 (CAT): 50% relaxation in tuition fee for the 1st year only.

Other than meritorious grounds, University also offers scholarship to non-meritorious students on the following criteria.

1. **Girls Quota**: In this category every girl child seeking an admission in any of the courses as listed for scholarship will be given 10% relaxation of the total tuition fee for the 1st year only.
2. **Disability Quota**: In this category, any student with physical disability with a medical proof in hand from govt. recognized competent authority is eligible for 10% relaxation in tuition fee for the 1st year only.
3. **Sports Quota**: In this category of scholarship, any student who is seeking admission in listed courses, is eligible for scholarship in tuition fee only for the following criteria:
 - a. International Level : 75% of the tuition fee for the 1st year only.
 - b. National Level : 50% of the tuition fee for the 1st year only.
 - c. State Level : 25% of the tuition fee for the 1st year only.
 - d. District Level : 10% of the tuition fee for the 1st year only.
4. **Defence Quota**: In this scholarship, every student seeking admission is eligible for 20% relaxation in the tuition fee for the very 1st year subject to the submission of valid ID proof by any of the parent serving in the defence.
5. **Champion (Existing student) quota**: This scholarship is only for the existing student who is pursuing any programme and has qualified the university examination is eligible for 25% relaxation in the tuition fee.
6. **Aptitude Test**: In this scholarship, the top 3 rank holders are eligible for the scholarship of 25%, 20% and 15% respectively in the tuition fee for the very 1st year only.
7. **SUNAT**: In this category of scholarship, university conducts an in-house entrance test wherein if any candidate qualifies than he/she is entitled for scholarship as per the marks obtained. The criteria for scholarship is as:
 - a. 90% and above : 50% relaxation in the tuition fee for the 1st year only.
 - b. 85% - 89.9% : 30% relaxation in the tuition fee for the 1st year only.
 - c. 80% - 84.9% : 20% relaxation in the tuition fee for the 1st year only.
 - d. 75% - 79.9% : 15% relaxation in the tuition fee for the 1st year only.
 - e. 70% - 74.9% : 10% relaxation in the tuition fee for the 1st year only.
8. **Chancellor's scholarship for UG programmes (after 10+2)**: In this category of scholarship any student who is seeking for admission in UG courses offered by the

university, then he/she is entitled for this benefit on the basis of their percentage of marks obtained in senior secondary education.

The criteria to avail this scholarship is as:

- a. 75% - 80.9% : 10% relaxation in the tuition fee for the 1st year only.
 - b. 81% - 85.9% : 25% relaxation in the tuition fee for the 1st year only.
 - c. 86% - 90.9% : 50% relaxation in the tuition fee for the 1st year only.
 - d. 91% & above : 100% relaxation in the tuition fee for the 1st year only.
9. **Chancellor's scholarship (During programme for subsequent years):** In this category every student who has taken the admission in the respective course, he/she is entitled for scholarship while pursuing the course on the basis of the marks obtained by him during the subsequent years. The criteria to avail this scholarship is as:
- a. 8.6 - 8.8 CGPA : 20% relaxation in subsequent year's tuition fee.
 - b. 8.81 - 9.0 CGPA : 40% relaxation in subsequent year's tuition fee.
 - c. 9.01 - 9.29 CGPA : 50% relaxation in subsequent year's tuition fee.
 - d. 9.3 CGPA & above : 100% relaxation in subsequent year's tuition fee.

Scholarship can be terminated:

- If it is determined that the awardee fails to fulfill an admission requirement or a condition on their continuing enrolment, or fails to maintain satisfactory progress.
- If the awardees' enrolment is terminated for any reason, or the awardee is found guilty of a Serious case of academic or research misconduct, or the awardee fails to maintain his/her enrolment.
- If the awardee relinquishes the Scholarship or withdraws from the course.

Scholarship/ Commendation Certificate Distribution

- The SS Committee will be responsible for the organization and Coordination of Scholarship presentations.
- The SSC will prepare the scholar's certificate in line with the protocol of certificate. The Certificate will be affixed with the signature of the Principal and the Head of SS Committee.

The college intends to pursue a programme of continuous improvement in its procedures and practices of Scholarship Policy. It shall review the policy on a regular basis to evaluate its continued relevance and to monitor compliance.
